INTRODUCTION

The publication of Delta Agriculturist Journal is intended to bridge the gap between theory and practice by bringing the results of research activities to farmers, extension workers and industrialists. The journal will accept and publish well researched articles and review papers in a wide range of agricultural disciplines including crop, soil and food science; agricultural engineering, food processing, fisheries, aquaculture and agricultural economics, extension and agriculture-related topics from other disciplines. The journal has been in publication since 1981 by the Faculty of Agriculture in the then Rivers State University of Science and Technology, Port Harcourt, Nigeria (now, Rivers State University).

MANUSCRIPT PREPARATION

It shall consist of the following sections: **Title, Abstract, Introduction, Materials and Methods, Results, Discussion, Conclusions, References.**

TEXT

The manuscript should be written in English (British), font type, Book Antiqua, font

size **10** for **Abstract** and **12** for **Introduction, Results and Discussion**, respectively; justified with margins, 2.5cm. The whole document must be prepared in black and white colour. Section headings should be in lower case, bold and left aligned. SI units should be used. Arabic numerals less than ten should be written in words. The whole manuscript should not exceed 10 pages, typed two spacing on A4 paper.

TITLE

The titled should written I upper case, should not exceed 18 words and must aptly describe the content of the manuscript. Where application, scientific names must written appropriately and local name should be included.

AUTHORS' NAME AND AFFILIATION

There should be a line space between the title and authors' name(s) beginning with the surname and the other names initialized, separated by a comma. The affiliation should follow on the next line. If the authors have more than one institutional affiliations Arabic numerals, superscripts should be used to provide the link. E-mail address and phone number of

corresponding author should be provided below it.

ABSTRACT

It should be a summary of the objectives, scope, methods applied, findings and conclusion(s). Maximum 200 words.

Key words: Maximum of five for indexing.

INTRODUCTION

Gives defined background information, problems investigated, justification and objectives of the study.

MATERIALS AND METHODS

Include details of the approaches, equipment and tools employed in the study. Procedures, including the design of the study must be clearly stated such that can enable reproducibility.

Study Area: It should be with art drawings of very good quality indicating where the study was carried out. Or else the location can be identified with **longitudes and latitudes**. **Coloured or scanned photographs are not accepted.**

RESULTS

Where necessary, data obtained must be **MUST** be subjected to appropriate statistical analysis. Outcomes of the study should be

explained using graphs and tables where they best explain them. Titles of tables, figures and plates (photographs/photomicrographs) must in black and white, single spaced, boldface, numbered in Arabic numerals and referred to in the sequence they occur in the text (that is, after the page of first mention). Table format should be used in its preparation. One horizontal line each should demarcate table heading and another at the end. Title of figure should be at the base (e.g. Fig. 1), while caption of tables must be on top. **Same information should not be repeated in both table and graph, but rather in whichever that best explains the information.** Graphs (figures) should be done with MS Excel and should not have borders. The excel file where the graphs were made must be include. **Tables and graphs must be in black and white. They must be self explanatory enough without reference to text**

DISCUSSION

It should give detailed interpretation of the findings, relate to those of previous studies, giving possible reasons for the differences or indicate whether it is similar to other studies, and the significance and implications.

CONCLUSION The major findings from the study should be summarized briefly.

ACKNOWLEDGMENT

This should specifically mention those who have made valuable contributions

to the success of the study, but are not among the authors.

REFERNECES

Authors are responsible for the accuracy of their citations. They should ensure completeness, consistency and accuracy. Citations in the text should follow the Author date system (last name of the author, year for single authors; author and author, year for two authors and author, *et al.*, year for three or more authors. *Pers. comm.* should be used for personal communication with author (s); *in press* for articles accepted and in the process of being published. The reference section should generally follow APA style (alphabetical) which includes the author(s) names, year of publication, full title of the paper, journal volume and page numbers. Journal titles should be written in full and italicized.
